In case of failure of supplying of materials and/or execution of the total work within the scheduled date without valid reasons, penalty will be imposed @ 10% per month of the amount put to tender and your name as a contractor is liable to be black listed by this Block Development office / Panchayat Samiti and/or you will be debarred from the facility of attending subsequent tenders/quotations of this Block Development office/ Panchayat Samiti for one year as be deemed fit by the authority of this Block Development office / Panchayat Samiti e alongwith forfeiture of your standing earnest money through rescission of your tender .
