Mixing water shall be clean and free from oil, acids, alkalis, salt, organic material or substance which may deleterious to concrete.

- 13. All the concrete shall be machine mixed & the concrete mixer shall be clean at all times.
- 14. The concrete shall be placed in its final position as soon as possible and in any case not later than half an hour after mixing.
- 15. The concrete shall be transported from the mixer to the position of placing in such a manner that segregation of the mix shall not occur.
- 16. Suitable side drains should be provided to prevent stagnation of water and it should be connected with suitable out falls for the disposal.
- 17. Not be permitted to walk over freshly placed concrete until it has hardened sufficiently to carry their weight without distortion, also to Barricade the road from both of the end till initial setting of the concrete.
- 18. The Form work must be uniform in length & be removed after 12 hours of completion of casting.
- 19. Expansion joints shall be provided at an interval of 10mtr apart and it should be perpendicular to cross section of road.
- 20. Camber shall be provided maximum 2.5% for Rigid Pavement.
- 21. Following the curing period, keep wet continuously for not less than seven(7) days after being removed from the forms.
- 22. According to order vide no. 594/ISGPP/20E-2(Proc)/39 the Gram panchayats are allowed to utilize 0.5% of estimated value of a scheme out of block grant of ISGPP Project for meeting unforeseen expenditure(Contingency) and for monitoring and supervision of schemes.
- 23. If contractor should not be started work within 7(seven) days from date of work order without showing any proper reasons to the undersigned ,the work order should be treated as canceled without sending any notice to the concern agency/contractor

24. No extra carriage charges should be provided to the agency/contract, So they are requested to visit the proper site
